# PROPOSED SPIN-OFF AND LISTING OF THE COMPANY'S INTERIOR FIT-OUT BUSINESS – LODGEMENT OF THE PRELIMINARY OFFER DOCUMENT

#### Introduction

The board of directors (the "Board") of Lum Chang Holdings Limited (the "Company" and together with its subsidiaries the "Group") refers to the Company's earlier announcement on 21 November 2024 in relation to the Proposed Spin-Off of the Interior Fit-Out Business and Listing of Lum Chang Interior Pte. Ltd. (the "Announcement"). Unless otherwise defined, capitalised terms used herein shall have the meanings as ascribed in the Announcement.

In connection with the Proposed Spin-off Listing, an internal restructuring exercise was carried out to transfer the LCI Group to a newly incorporated subsidiary, Lum Chang Creations Pte. Ltd. ("LCC"). Subsequent to the internal restructuring, LCC was converted to a public company on 19 June 2025 bearing the name of Lum Chang Creations Limited. Pursuant to the Proposed Spin-off Listing, LCC proposes to undertake the proposed listing on the Catalist board of the Singapore Exchange Securities Trading Limited ("SGX-ST").

Further to the Announcement, the Board wishes to announce that RHT Capital Pte. Ltd., who has been appointed as the issue manager and full sponsor for the Proposed Spin-off Listing, has today, on behalf of LCC, lodged the Preliminary Offer Document of LCC dated 23 June 2025 with the SGX-ST, acting as agent on behalf of the Monetary Authority of Singapore (the "MAS"), in connection with the Proposed Spin-off Listing.

The Company and LCC's decision to proceed with the Proposed Spin-off Listing will be subject to, among other things, investor demand and prevailing market conditions. The Company will make further announcements as and when there are further material developments in relation to the Proposed Spin-off Listing.

Shareholders and potential investors are reminded to exercise caution when dealing in the securities of the Company and should consult their stockbrokers, bank managers, solicitors, accountants or other professional advisers if they have any doubt about the actions that they should take.
